Образложење

Законом о посебним условима за евидентирање и упис права на непокретностима (Сл. Гласник РС“, бр. 91/2025), чланом 27. став 1. прописано је да ступањем на снагу овог закона престаје да важи Закон о озакоњењу објеката („Сл. гласник РС“, бр. 96/15, 83/18, 81/20 – одлука УС, 1/23 – одлука УС и 62/23), ставом 2. истог члана прописано је да поступци започети у складу са одредбама Закона о озакоњењу објеката за објекте прописане у члану 1. закона, обустављају се даном ступања на снагу овог закона. У ставу 3. истог члана прописано је да се за поступке из става 2. не доноси посебно решење о обустави поступка, већ колективно решење.

Имајући у виду да је Закон о посебним условима за евидентирање и упис права на непокретностима (Сл. Гласник РС“, бр. 91/2025) ступио на снагу 24.10.2025. године, донето је колективно решење као у диспозитиву, у циљу обуставе свих започетих поступака по сили закона, без доношења посебних решења о обустави.

Ово решење постаје правноснажно даном доношења и против њега није допуштена жалба, с обзиром да се заснива на непосредној примени закона.
